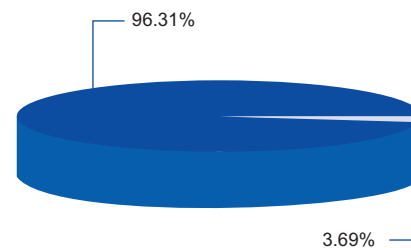

■ Money Market Instruments ■ Cash & Cash Equivalent



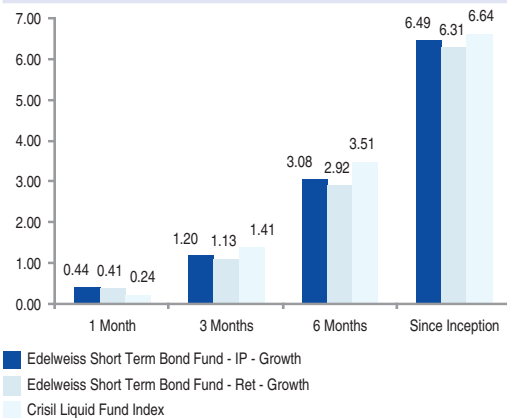
