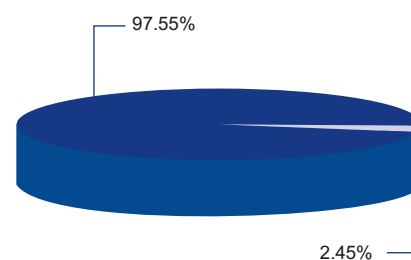

Asset Allocation

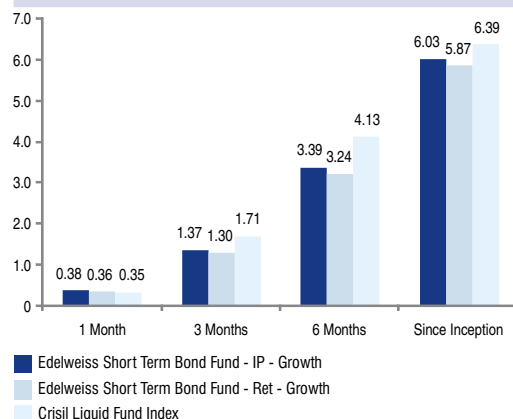
■ Money Market Instruments ■ Cash & Cash Equivalent
