The Indian Government signed an Inter-Governmental Agreement (IGA) with the United States (US) on 9th July 2015 to implement the Foreign Account Tax Compliance Act (FATCA) in India. 10. In case applicant/unit holder has any of the Indicia pertaining to a foreign country and yet declares self to be non-tax resident in the respective country, investors to provide relevant details as may be asked for.
11. However, if the investor has provided these details already in response to any request from the Fund, then they may choose to ignore this section.
