



SEBI vide circular SEBI/HO/MIRSD/FATF/P/CIR/2023/0144 dates 11th August 2023, as a risk management framework advised that KYC Registration Agencies (KRA) shall verify the following attributes of KYC:



The records of those clients in respect of which all the above attributes are verified by KRAs with official database (such as Income Tax database on PAN, Aadhar XML/Digilocker/M-Aadhar) shall be considered as validated records.

KYC status can be KYC Validated, KYC Registered or KYC On Hold/Rejected.

KYC may not be validated despite submitting Aadhar due to below reasons:

- * Aadhar QR code is not readable
- * Online Aadhar validation is not completed
- * PAN Aadhar seeding is not completed
- * Email/mobile validation is not completed or has failed
- * Email/mobile registered in KYC is incorrect
- * KYC and Aadhar data is not matching

Steps for re-KYC or Modification of KYC



Online re-KYC

- Visit www.edelweissmf.com
- Login into your account.
- Click on your name appearing on the top most right corner of the page
- Further click on re-KYC
- Keep your PAN, Digilocker account details, Aadhar number and signature ready.
- You will need to keep web camera of your desktop/laptop on.
- Follow the instructions on the screen in order to complete your KYC.
- Once the process is successfully completed, share the screenshot of successful page by reverting to this email for us to further look into the transaction.
- We will confirm to you on the status of your application.

Offline re-KYC

- Take a print, fill up all details and submit to the nearest AMC branch or Kfintech ISC along with supporting documents.
