  The Distributor agrees that pursuant to signing this form, Investment Manager through its Registrar and Transfer Agent will dispatch to the Distributor's PIN by post/courier to the Distributor's recorded address with the Investment Manager. It is the distributors responsibility to confirm receipt of the PIN to the Investment Manager, forthwith notify the Investment Manager in the event of evidence of tampering with the PIN in the course of post, or non-receipt of PIN, as the case may be.
- The Distributor will have the facility to generate an administrator user name and password for further allotment of user names and passwords for multilevel access to their
  employees/sub brokers and other users authorized by the Distributor, which will enable them to view the transactions. The administrator user will also create e-mail ids to
  receive various transaction and other business details. The decision of the Investment Manager/ Registrar and Transfer Agent on the number and types of access for the
  Distributor shall be final and binding.
